Healthy teeth and gums are essential for healthy growth and development, as well as later in life. Healthy teeth are not only important for chewing our meals, but also for speech development, among other things. Daily regular tooth brushing, e.g. in the mornings and in the evenings, helps to protect against dental diseases.

A dentist usually comes to the daycare centre every year on behalf of the Dental Health Working Group and gives the children their dental check-ups. The documentation of the dental findings at the health department will be deleted after 4 years. Participation in the check-up is voluntary. Please give us your consent to the dental check-up and to the processing of personal data (name of the institution, name of the child, age, dental findings). using the attached form (on the reverse side). We will inform you about the results of the dental check-up, for which we will give your child a sealed letter with their name on it.

A prophylaxis specialist from our working group will usually also visit the centre. He or she will inform the children in an age-appropriate way about the importance of oral hygiene, proper brushing and healthy eating. You can find out the exact dates at the daycare centre.
